

Job Title: Financial Reporting Senior Analyst

Summary: The Financial Reporting Senior Analyst is responsible for assisting in the external

financial reporting process for the Company, researching accounting policies, standards and regulations, and performing the accounting for complex technical accounting issues. Additionally, the Financial Reporting Senior Analyst will participate in the execution of the Company's Sarbanes-Oxley (SOX) efforts.

Responsibilities:

Responsibilities include, but not limited to:

- Assist in the preparation and filing of timely SEC quarterly and annual reports
- Assist in the preparation of the annual and quarterly financial statements, footnotes, MD&A input, etc., and maintain supporting documentation.
- Review the XBRL filings and other schedules related to the quarterly earnings release.
- Research and provide guidance on technical accounting issues.
- Prepare stand alone and statutory financial statements for non-public subsidiaries
- Responsible for monthly and quarterly analysis of key accounts, e.g. equity (EPS, Restricted Stock, etc.), pension accruals, goodwill, long-lived assets and intangibles impairment analyses, and any others as deemed necessary
- Assist in the execution of the Company's Sarbanes-Oxley compliance program, including:
 - Coordination of audit programs with third party internal audit function
 - o Maintenance of certain key control spreadsheets
 - Updating the Company's documentation related to processes and controls
 - Testing of certain controls
- Staying abreast of changes in SEC requirements, US GAAP, and SOX requirements.
- Support the audit process with external auditors.
- Assist with special projects, such as asset acquisitions, dispositions, financial instrument valuation work, opening balance sheet allocation, etc., as applicable.
